

MORRIS COUNTY TRAIL CONSTRUCTION GRANT PROGRAM

2020 FACT SHEET

SOURCE OF FUNDING: Originating from the Morris County Preservation Trust Fund, on November 4, 2014, the voting electorate of Morris County approved the ballot question by a margin of nearly 3 to 1 to permit trail development as an allowable use under the Trust Fund.

PURPOSE OF FUNDING: The purpose of the grant program is to provide recreational trail use opportunities, which benefit the communities and enhance the quality of life for the residents of Morris County.

WHO IS ELIGIBLE: Any of the thirty-nine municipalities in the County of Morris, New Jersey. Municipalities are limited to one application per funding cycle.

PERMISSABLE USES & PROJECTS:

1. Construction of new trails of various surface types (motorized and non-motorized).
2. Trail Enhancement (improvements of trail design and/or surface type of existing trails to accommodate increased volume and/or make the trail ADA compliant. Trail Enhancement is more than an in-kind replacement of current conditions, and is not intended to address deferred maintenance issues.

REQUIRED QUALIFICATIONS: The land on which the trail is to be funded must be:

1. Located in Morris County
2. Owned by the municipality, in full and/or via permanent easements on which trail(s) are to be located.
3. Permanently preserved public parkland or private land with permanent easements dedicated for public trail/recreational use.

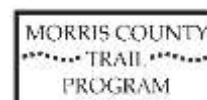
PROGRAM FUNDING: The program will operate on a reimbursement basis. The minimum grant amount is \$5,000.00. The maximum grant award limit is defined as “no one award shall receive more than 60% of the funds available during each year’s funding cycle”. However, this exception can be waived if the project is deemed to be a regionally significant project.

MATCHING FUNDS: Applicants are required to provide a 20% match (minimum). The match can be made up of a combination of sources including:

- Direct Costs (labor, materials, equipment)
- Indirect Costs (limited to planning, engineering, and permitting costs)
- Other grant resources
- Municipal Funds (Open Space, capital, etc.)

APPLICATION PROCESS: STEP 1 - Applicants are required to submit a completed Letter of Intent. This documentation verifies property ownership and outlines preliminary project costs. STEP 2 - Applicants are required to submit a completed application, which consists of 11 sections including a detailed cost estimate and relevant design documentation.

PROGRAM UPDATE: Anticipated program changes will not be implemented due to the impacts of COVID-19. The rules, regulations, and application procedures of the 2020 Trail Construction Grant program will remain the same as last year. Therefore, we will not be holding a Program Update Meeting. We encourage applicants to contact the Program Coordinator to schedule a Pre-application meeting to help guide your project and application.

PRE-APPLICATION MEETINGS: Pre-application meetings are required for ALL first time applicants. Pre-application meetings are typically held to review and discuss individual applications prior to the application deadline. Pre-application meetings will be scheduled on a first-come first-served basis throughout the open application cycle. We anticipate that Pre-Application meeting will be held via video or conference calls.

APPLICATION DEADLINE: Monday August 31, 2020 at 4:00 P.M.

QUESTION & ANSWER SESSION: Thursday October 29, 2020 (estimated)

AWARD NOTIFICATION DATE: December 2020

PROJECT COMPLETION: 3-years (as defined in grant agreement)

NON-ELIGIBLE USES: Various aspects of project development are not eligible for funding as part of this grant program; they include but are not limited to the following:

1. Land Condemnation
2. Land Acquisition
3. Trail feasibility studies
4. Planning
5. Design
6. Sidewalks
7. Improvements or construction to roads
8. Lighting
9. Running tracks (tracks used for races involving athletes at track meets)
10. Law enforcement personnel & activities
11. Promotional materials (shirts, caps, pins)
12. Purchase of equipment
13. Deferred Maintenance
14. Administrative and grant preparation fees
